Behavior Analysis Registering Your Agency with Tellus EVV



Who Needs to Register their Group?



- One initial System Administrator per Group.
 - Once the initial System Administrator is registered, this person may invite others in their Group to become System Administrators.
 - Individual providers/users of the system will NOT need to register on their own. When a System Administrator links a Provider/User with a BA Group, an automated email will be sent to each user to confirm their user name and a reminder to set up their unique password the first time they log in to the Tellus eVV System.
- Lead Analysts who submit their own claims directly for payment must also register as a System Administrator.

Registration available

- 1) Choose an initial EVV System Administrator to register the Group (Lead Analysts submitting their own claims must register to gain system access).
- Initial System Administrator and/or Lead Analyst (that submit their own claims) will complete the AHCA BA EVV Registration form @ <u>https://4tellus.com/ahca-ba</u> on the Register for EVV tab which will create an initial company profile.
- 3) System Administrator/Lead Analyst (that submit their own claims) will receive User Name and will be prompted to create a unique password the first time they log in.
- 4) System Administrator/Lead Analyst (that submit their own claims) will log in to Tellus @ https:4tellus.com

System Administrators will link the Providers (Users) to their Group. This process of linking the Users with the BA Group will trigger an automated email to each User with their user name and password, which will allow them to log in to the Tellus eVV System on their Mobile Application.
